4 Terms and Conditions

4.1 Eligibility of Candidates

The following terms and conditions apply to the submission of candidacies for all open positions.

- 1. Candidates must run for elections as individual persons but must be proposed by OpenPeppol members.
- 2. Each candidate for a position to be elected by the 15th OpenPeppol General Assembly must be proposed by an OpenPeppol Member that belongs to the same member category as the open position is intended to represent (i.e. to run for a position of a Peppol Authority representative in the Managing Committee, a candidate must be proposed by a Peppol Authority member).

- 3. Each candidate for a position to be elected by a Community must be proposed by an OpenPeppol Member that is also a member of the respective Community, as described in section 3.2 above.
- 4. All OpenPeppol Members, except Observers, have the right to propose candidates for open positions, subject to the terms and conditions in this section.
- 5. The candidates proposed by an OpenPeppol Member should have a regular professional relationship with that member. They must also have ensured that their working relationship allows for a minimum of 12-15 working days per year (double for the Secretary General) that can be devoted to their function as elected officials in OpenPeppol, as well as for coverage of travel expenses related to their position.
- 6. Candidates can run for more than one open position, subject to the terms and conditions in this section.

The OpenPeppol Election Committee will be responsible for determining whether the above conditions are met by candidates proposed under the present Call for Candidates.

4.2 Submission of candidacies

Candidacies for all open positions should be submitted by sending a **Notification of Candidacy** by email to the address <u>candidates@peppol.eu</u>.

The Notification of Candidacy should include or enclose the following information:

- 1. Name of Candidate
- 2. Position(s) the Candidate is running for
- 3. Name of OpenPeppol Member proposing the Candidate
- 4. Professional relationship of Candidate and Proposing Member
- 5. Curriculum Vitae of Candidate (short)
- 6. Motivation letter, outlining the Candidate's vision for the position(s), for which the Candidate is running

All information included in the Notification of Candidacy shall be made duly available to Members ahead of the vote.

4.3 Deadline for submitting Candidacies

Candidacies should be submitted no later than April 28th, 2023.

In case there is an insufficient number of candidates with respect to the number of open positions by that date, the deadline can be extended following a decision by the OpenPeppol Election Committee.



4.4 Validation and Announcement of Candidates

The OpenPeppol Election Committee will review all candidacies submitted and determine if they are in line with the criteria and conditions outlined in the present Call for Candidates.

All eligible candidates will be formally announced no later than **May 3rd, 2023**. Candidacies will be displayed at a publicly accessible location as they come in, even before the deadline, after being validated by the Election Committee.

4.5 Milestones and Timeline

4.5.1 Important days for General Assembly elections

- March 28th, 2023: MC decides to launch the Call for Candidates 2023
- March 28th, 2023: Call for Candidates is published
- April 28th, 2023: Deadline to submit candidacies
- May 3rd, 2023: Deadline for Election Committee to validate candidacies
- May 3rd, 2023: Announcement of Candidates
 - The deadline for submitting candidacies has to be extended under the circumstances foreseen in section 4.3 above.
- Date to be decided: GA preparation meeting presentation of candidates who will have the opportunity to address the OpenPeppol Members
- June 8th, 2023: Live voting during the 15th General Assembly and announcements of the results

4.5.2 Important Dates for Communities elections

- March 28th, 2023: MC decides to launch the Call for Candidates 2023
- March 28th, 2023: Call for Candidates is published
- April 28th, 2023: Deadline to submit candidacies
- May 3rd, 2023: Deadline for Election Committee to validate candidacies
- May 3rd, 2023: Announcement of Candidates, opening of the voting period
 - In case the deadline for submitting candidacies has to be extended under the circumstances foreseen in section 4.3 above, the voting process will open at a later date.



- June 2nd, 2023: Closing of the voting period
- June 6th, 2023: Election Committee validates the results
- June 8th, 2023: Results are announced during the 15th General Assembly
